SIKSHYA JYOTI AWARD

- 1. The Governing Body in their session No. 5 on 12.12.2019 resolves that there shall be provision for felicitating a teacher in every Academic year starting from this session i.e. 2019-20 in name of an Award 'SIKAHYA JYOTI' with a provided one is credible and deserving to receive the honour in view to inspire the teachers working in this institution to become more focussive, responsible and credible in the field of teaching and academic excellence. This award is founded only for the recognition/ felicitation of a successful Teacher working in this institution and is in no way a commercial authoritarian on or tutorial in nature.
- 2. 'An Academic year' means the day of reopening of a new academic session till closure of the institution resuming summer vacation.

3. The Type of Award

The type of award is institutional and it cannot be shifted to any other place or purpose. The award is given from the Administrative Governance within the jurisdiction of Governing Body of the College under direct supervision of the Head of the Institution namely Principal- Cum- Secretary, Gopalpur College, Gopalpur, Balasore. This award consist of a Testimonial of honour including felicitation and a cash prize of Rs. 3000/-(Rupees Three thousand only). The cost of expenditure for some award will be met from 'Teacher Welfare Fund' of the college.

4. Eligibility for the Award

A teaching member on a pare teacher who has served this institution at least two complete years at a length and contributed his/her devoted service for all-round development of the students of the college in general will be the minimum criteria for the award. He/she must process creative idea and innovative mind to aid and assist in academic excellence, overall growth and progress of the institution. He/she must possess communicative power, good moral ethic, well-versed and commanding power over his/her stream of knowledge, research work, publication literary activities, cultural, physical, moral and social education of the community of the students as a and public. He/she must have contributed for new teaching devices, assisted the students a mentor for their excellence. He/she must not have been punished by the Government college authorities or any other legal bodies for an act of disloyalty, misconduct or crime.

Selection Board

There shall be a Selection Board conducting to nominate the awardee for the Academic Session. The committee will have five members headed by the Principal cum Secretary as its Chair Person. The Administrative and Academic Bursar, staff council secretary, Co-ordinator of IQAC will be its ex- officio member. If any of them who coveted such award shall be withdrawn from committee and his place will be filled in with a senior most Lady-Teacher of the college.

Function of the Selection Board

The function of the Selection Board is to collect feedback about the expect awardees from the stakeholders to enter the same rank such as benchmark of the index of honour.
