COPALPUR BALASORE GRIVANCE REDRESSAL MECHANISM

Gopalpur College, Gopalpur, Balasore maintains effective mechanism to redress the grievances received from different angles it takes care to upkeep discipline peaceful atmosphere and civic laws prevailing in the campus. A number of committees are constituted vide notification No. 68 dated 1.08.2019 to take up the matter of appeal relating to insubordination, disrespect, obscene behaviour, ragging, sexual torture, physical assault, dishonour to weaker group and threat to others etc. Some of the grievance Redressal mechanism adopted in the campus are referred hereunder.

Committee for Prevention of Sexual Harassment

One of the core objectives of the College is to ensure gender equity and gender justice. In keeping with this principle, it is important to ensure an atmosphere, free from discrimination and harassment, in the campus particularly focusing on prevention of sexual harassment.

The College takes allegations of sexual harassment seriously, maintains record in Complaint Register and responds promptly to the complaints of sexual harassment. Where it is determined that such an inappropriate conduct has occurred, dishonouring someone, giving sexual harassment and showing obscene behaviour very prompt and appropriate corrective action as necessary, including disciplinary action, are taken. The concerned allegated person is summoned to confresh to keep his strand before the matter is resolved. The policy sets forth the goal of the College for promoting a healthy study environment or honourable situation in the workplace that is free of sexual harassment. The college restrict its stakeholder to behave offensively and prohibits to show any sort of sexual harassment.

A committee has been constituted to deal with the matter relating to sexual harassment vide the letter No. 2278 dated 19.01.2018 Govt. of Odisha The following members have been taken in to the committee for prevention of all sorts of sexual harassment in the college campus.

Anti-Ragging Cell

As per government guidelines and UGC rules ragging in any manner has been prohibited in the college campus. Anyone detected to have been engaged in such an act of impoliteness anyway or someone lodges complaint of being victimised to any forceful activities before the authority is booked under the charges to face an official trial to comply with his/her aggressive nature. Any form of coercion, offensive activities, physical torture, to carry out on just order, compelling someone to behave impolitely are treated as ragging.

General Conduct Rules and Guidelines

While the students as adult citizens of the country enjoy their rights, they also are expected to be aware of their responsibilities. The College will not support any act that is illegal as construed by the law of the land. The college encourages an all round development of students' personality, their progressive and creative thinking. At the same time, in order that they effectively discharge civic responsibilities and virtues, the college sets its own terms of conduct that must be adhered to by the students. Any deviation to normal discipline the Disciplinary/ Administrative Action are taken against those miscreants.

A student found indulged in ragging can be subjected to:

- i) Being Debarred from attending Classes
- ii) Being expelled from appearing Examinations
- iii) Ordered Cancellation of Admission and rustigetted from the college.
- iv) Initiated of criminal action.
- v) Sought a promise undertaking not to repeat such action in future.

In pursuant to Government of Odisha letter No. 14593 dated 17.04.2017, an internal committee of discipline was formed to listen students grievance. This earlier internal committee of discipline was renamed as Anti raging Cell vide letter no 133 dated 8.8.2018, of Regional Director of Education to implement administrative action.

In order to solve the cases related to ragging of stakeholders a Committee named 'Anti-Ragging Cell' has been formed in the college with the following

GRIEVANCE REDRESSAL COMMITTEE




