Terms of the award

 The award will be given annually to the College Toppers in final Higher Secondary Examination and Degree Examinations. This will continue unbreakably until the fund exists.

Place of the award

3. The place of Award will be only Gopalpur College, Gopalpur, Dist-Balasore and the Principal of the College by designation shall be the authorised person to manage the account. ### Objectives:

- The Equal Opportunity Cell is a welfare agency founded under Promotion of Equity in Higher Education Institution Regulation Act. 2012 of the Government of India.

Cost of Award
